



The **UN General Assembly (UNGA)** is the only *universally representative body* of the five organs of the United Nations. It is the main deliberative organ of United Nations. The function of the General Assembly is to discuss, debate, and make recommendations on a range of subjects pertaining to *International peace and security* - including development, disarmament, human rights, international law, and peaceful arbitration between disputing nations.

One of its primary role is to forge friendly bonds among its member countries on the basis of the respect for the principal of equal rights and self-determination and show solidarity with millions of people. After meaningful debates on topics of international interest, conclusive recommendations are made to the members.

Maritime security functions are performed by a wide range of actors in fields such as maritime transport, fisheries inspection, border control, law enforcement and other authorities. 



Promoting human rights since 2006, the *United Nations Human Rights Council* is an intergovernmental body with 47 member states. A subsidiary body of the UN General Assembly, the UNHRC is vocal about issues including, but not limited to, freedom of religion, women's rights, freedom of expression, rights of racial minorities etc. Notably, the UNHRC, to considerable success, addressed the Israel-Palestine conflicts and strived for human rights establishment in the war torn states.

The members for the 47 seats are elected by the General Assembly members. Each member holds the seat for a term of three years, and can occupy it for not more than two consecutive terms.

It is responsible for strengthening the *promotion and protection of human rights* around the globe and for addressing situations of human rights violations and make recommendations on them. It has the ability to discuss all thematic human rights issues and situations that require its attention throughout the year. It meets at the UN Office at Geneva.

# Right to Privacy with special reference to Surveillance

Stated explicitly under Article 12 of the Universal Declaration of Human Rights, the right to privacy asserts: "No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation.

Everyone has the right to the protection of the law against such interference or attacks." Despite universal laws governing the right to privacy, governmental organisations such as the NSA, CIA, and GCHQ continue to conduct mass surveillance throughout the world, leading to the privacy laws coming under the scanner.

Therefore, argument in favour of privacy is fast gaining critics and has now become a contentious issue worldwide, ever since it acquainted the public with the perceived need of nations to spy on the general population in a bid to maintain their power structures.





The UN Security Council, formed in 1946 has the primary duty to *maintain international peace and security*. The council comprises of 15 members out of which the People's Republic of China, French Republic, Russian Federation, United Kingdom of Great Britain and Northern Ireland, United States of America have *permanent seats and the power to veto resolutions*. The other ten nations, are voted upon by the General Assembly to have a seat for two years in the Security Council.

The security council takes the lead in determining the existence of a threat to the peace in act of aggression. It calls upon the parties to a dispute to settle it by *peaceful means and recommends terms of settlement*. The SC can resort to imposing sanctions or even authorise the use of force to maintain and restore international peace and security.

When dispute leads to hostilities, the council's primary concern is to bring them then to an end as soon as possible. In this case the council may, issue ceasefire directives that can help prevent as escalation of the conflict; dispatch military observers or a peacekeeping force to help reduce tensions, separate opposing forces and establish a calm in which peaceful settlements may be sought. Beyond this, the council may opt for enforcement measures including : economic sanctions, financial penalties and restrictions and Travel band; severance of diplomatic relations, blockade or collective military action.




# The question ofSelf Determination with specialreference to Responsibility to Protect

The Responsibility to Protect has become a prominent feature in international debates about preventing genocide and mass atrocities and about protecting potential victims.

The primary responsibility of states is to protect their own populations from the four crimes of genocide, war crimes, ethnic cleansing, and crimes against humanity, as well as from their incitement. Essentially, the right to self-determination is the right of an individual to determine its own destiny. In particular, the principle allows the people to choose its own political status and to determine its own form of economic, cultural and social development. Exercise of this right can result in a variety of different outcomes ranging from political independence through to full integration within a state. With ambition of becoming self determined comes the Responsibility to Protect which states that sovereignty is not an absolute right, and that states are bounded to protect their populations from mass atrocity crimes and human rights violations.











### Reviewing India's Foreign Policy with special reference to its neighbouring countries


India's foreign relations reflect a traditional policy of nonalignment, the exigencies of domestic economic reform and development. Until a decade ago, India was regarded largely as a poor developing country with low visibility on the global political and economic front. A multitude of factors, most prominently its emerging global economic strength, have led India not only to redefine its self-image but also to adopt a new political role both internationally and within its immediate neighbourhood.

It is argued that India's attempts at development cooperation in the neighbourhood and encouraging bilateral trade are driven, not just by economic concerns, but by a sharp realisation that its political capital in the neighbourhood is fast dwindling. India's foreign policy has always regarded the concept of neighbourhood as one of widening concentric circles, around a central axis of historical and cultural commonalities.


Free Press is an institution that keeps governments and organisations ticking, keeps the masses informed, and plays a vital role in not only forming public opinion but also voicing it.
